As stated in the *Quantitative Methodology Report*, unless otherwise specified, missing data are denoted in one of two ways. Responses were coded -88 if the question was not applicable, and responses were coded -99 if the respondent did not know or refused to answer the question. Users also should consult the *Quantitative Methodology Report* for the research team's recommendations on the use of the included weight variable (weight1).
