I. ABOUT THIS CODEBOOK

This codebook contains the names and coding for questions asked in Round 5 (October 2019-January 2020) of *Access to Durable Solutions Among IDPs in Iraq* and corresponds to all variables in the PANELFILE with the appendage "**5**". For information on variable name conventions, missingness, weights, and other survey design-related questions, please see the *Access to Durable Solutions Among Iraqi IDPs: Quantitative Methodology Report*.

I. NOTES ABOUT ROUND 5

As stated in the *Quantitative Methodology Report*, unless otherwise specified, missing data are denoted in one of two ways. Responses were coded -88 if the question was not applicable, and responses were coded -99 if the respondent did not know or refused to answer the question. Users should consult the *Quantitative Methodology Report* for the research team's recommendations on the use of the included weight variable (weight5).

In Round 5, questions on health that were previously in Section 14 were moved instead to Section 4 on Standard of Living. Instead, questions in Round 5 Section 14: Agriculture Module are designed to understand why IDPs who worked in agriculture, farming, and/or herding before displacement have not returned to this economic activity; the challenges they face if they have returned; and their future intentions as they relate to farming.

As in Rounds 2 through 4, some households in the study continued to move in Round 5: some returning to their districts of origin; some moved to other governorates inside Iraq. The study-defined variable denoting this status (IDP, Mover, Returnee) in Round 5 is **status5.** Definitions of each of these groups are as follows:

- **IDPs:** households displaced to one district in Round 1 and who remained in the same location throughout displacement
- **Movers:** households displaced to one district in Round 1 but who moved to another district subsequently
- **Returnees:** households displaced in Round 1 but who returned to their districts of origin in subsequent rounds.

Some questions were thus tailored to a certain subgroup. In Round 5, all questions for subgroups were moved to Section 15. Where all groups were asked the same questions, the responses are combined into one variable with no appendage. Where questions were asked only of IDPs/Movers or only of Returnees, the variable name contains the appendage IDP for IDPs/Movers and RT for Returnees.

In Round 5, question text, numbers, and structures of questions asked in previous rounds were pegged to those in Round 4. Prior to Round 4, however, in some cases, the question number, question structure, or response categories for the same question text did vary over time despite best efforts to maintain them as much as possible over the multiple rounds of the study. The codebooks for Rounds 2 through 4 provide notes alerting users to these changes whenever possible.
